FEES

REGISTRATION FEE: Paid at the time of registration with first month's tuition. This non-refundable fee ensures class placement. Fee is \$30.00 per student.

TUITION: Tuition is a set yearly fee and divided into 10 monthly payments for your convenience regardless of how many lessons pertain in a month based on Holidays, Absences, or Inclement Weather. Tuition should be paid at the 1st of each month; NOT the first class of each month (August-May). **Tuition Bills will NOT be mailed out monthly.** *It is your responsibility to make tuition payments on time and it is very important for us to receive payments on time. If an account is persistently overdue, we have the right to not allow your child to enter class.*

Tuition may be dropped off at the studio. If payment is turned in at the studio, please drop it in the mailbox. **Please do not turn any payments in to the teachers. Teachers do NOT have ANY information regarding your account.** To check your account status, your balance will be posted weekly by your phone number. Checks are the best form of payment. When paying with a check please put the name of the student on the memo portion of the check. There are **no receipts** for cash payments. If you pay with cash, please put payment in a sealed envelope with the student's name on the outside of the envelope.

PRIMARY CLASS: \$50.00 paid for 10 months
FAMILY RATE: 2 students \$90.00 paid for 10 months
FAMILY RATE: 3 or more students \$120.00 paid for 10 months

ADDITIONAL CLASSES: (Ballet, Jazz/Hip Hop, Lyrical, and Technique) \$35.00 monthly per class for each student.
(Only siblings qualify for family rates)

LATE FEES: There is a \$10.00 late fee if tuition is not paid before the 1st of each month. Tuition is considered late if it is not in the polka dotted mailbox before the studio closes by the 1st of each month, regardless of absences or holidays. Credit is not given for a monthly payment if your child does not attend class for the entire month. If you mail your payment to us, please mail it early to make sure it will not be late. Payment must be in hand before the 1st to be considered on time. (NO EXCEPTIONS.) *All costume deposits, costume remainders, and revue fees are subject to late fees if they are not paid by the due date on the invoice.* If paid after the due date, a \$10.00 late fee will be mailed out and applied to your account. At the end of the year you will not be able to get your revue seats if you have any outstanding late fees or balances. If you have any questions or concerns regarding your invoice, please call Braton at 985-624-5371.

Parent Responsibilities

Please come into the studio at least once a week to make sure you stay informed with any events taking place. We try really hard to keep you informed through email on upcoming events, important dates and deadlines. Please be sure to come in and read all information posted on the bulletin boards as well as ALL emails. Please make sure your email address with us is always current.

NON SUFFICIENT FUNDS CHECKS

All NSF checks will result in a \$25.00 fee and may be posted in the studio. Any NSF Check that is not paid within 10 days will be reported to the Parish District Attorney for collection.

HOLIDAYS

Holidays will be announced throughout the year. Please check the Bulletin Board in the waiting room for posted notices and other information that will occur during the course of the year. We will also have information posted on our website at www.kelliskreative.com.

INCLEMENT WEATHER

When weather conditions close public schools, the studio will most likely close. Classes will not be made up or reimbursed if cancelled due to weather conditions such as Hurricane's, flooding and or general bad weather. There will be NO refunds of any kind including registration fees, tuition fees, revue fees and costume fees in the event of a Hurricane or Natural disaster. In the event that any Kelli's Kreative Dance Studio suffers from severe damage there will be NO reimbursement of any fees paid.

WAITING AREA

A separate waiting area is available for parents who wish to wait for their child during class. We ask that all students wait in this room until class time. ***ABSOLUTELY NO FOOD OR DRINKS WILL BE PERMITTED IN THE BUILDING.*** We ask all parents who drop their children off to please be on time to pick them up. We hope that Kelli's Kreative Dance is a "Home away from Home", enjoy our waiting area, but please help keep it clean.

ANNUAL DANCE PRODUCTION

Kelli's Kreative Dance holds an annual dance production in the month of June. This completes our year of study and lets the parents see how the students have progressed throughout the year, while exposing the students to performing and giving them a sense of professionalism. *The first half of the revue fee is due on September 15th. The remainder will be collected October 15th. This fee includes one trophy for each student and one revue book per family. This fee also includes 6 seats for families with one student, 8 seats for families with 2 students and 10 seats for families with three students. This fee is **NON-REFUNDABLE!** If you choose to leave the studio for Any reason you will Not be refunded your payments toward the revue and you forfeit your trophy and revue book.*

REVUE FEE: (Non-Refundable)

1 student \$160.00	\$160/2 payments = \$80.00 due September 15 st and October 15 st
2 students \$210.00	\$210/2 payments = \$105.00 due September 15 st and October 15 st
3 students \$235.00	\$235/2 payments = \$117.50 due September 15 st and October 15 st

COSTUMES: All costumes are ready made and ordered from various companies. Any extra trim or sequins that is to be added to the costume(s) is included in the total price of the costume with the exception of rhinestones and some headpieces. Costumes are ordered the first week of December. Approximated cost: \$80.00 - \$130.00 per costume. A \$50.00 *non-refundable* deposit (per costume) will be taken in the month of November due on the 10th. The remainder will be collected in the month of January. *There is absolutely no refund on any costumes. In the event that you no longer wish to take lessons please notify the studio with a written document indicating that you will no longer continue dancing. If we do not have a written document, you will be responsible for the entire cost of the costume(s).* If the costume deposits are not paid in full by the due date, your child(s) costume(s) will **NOT** be ordered. *If an exchange or alteration needs to be made, Kelli's Kreative Dance will not take responsibility for any extra costs, or responsibility for how the costume is made. Teachers measure all students.* If you prefer to measure your own child, please send in their measurements along with your deposit. You will be solely responsible for the outcome. All extra large adult costumes have to be made special and **CAN NOT** be exchanged. There is an additional \$10.00 fee for XLA costumes as well.

REVUE DANCES: All students will be in one number in the Revue. 5th year and above tap & jazz combination classes will participate in two numbers (**upon the teachers discretion**). If a student takes a combination class along with an additional class, they will then participate in three numbers. **ATTENDANCE:** This will reflect on choreography for the revue dance. If your child is absent often, this will reflect on their placement in the dance. If a student is absent more than 2 lessons in the month of April & May, they may not be allowed to participate in the revue and the revue fee will NOT be refunded.

STUDENT AWARDS: Trophies are given to all students. Students with 5 years of dance or more will receive their trophy on stage at the end of the revue. Students who have transferred from other schools will have all previous dance years recognized.

DRESS CODE FOR CLASS

Combination, Lyrical, Hip-Hop, Jazz and Technique Classes: Dancewear, any color of leotard, sports bra & boy shorts. Hair should be off from face. Oversized shirts, school uniforms or shorts (other than boy shorts) will NOT be permitted! Students that abuse the dress code will be given a warning not to attend class again without appropriate dancewear. If they abuse the policy again, they will be asked to sit out from class. **This applies to ALL classes.**

Ages 2-5: Any color of leotard, tutu, skirt and tights of choice.

Ballet Class: Black leotard and pink tights only. Hair must be pulled all of the way off from face. A skirt is optional with pink ballet shoes.

Dance Shoes: Ages 2 ½ - 5 will need Bloch suntan leather tap shoes and pink Ballet shoes. All ribbons on tap shoes must be removed and replaced with elastic. Ages 6-9 will need suntan Mary Jane (Bloch brand) tap shoes with the buckle and suntan slip on jazz shoes (Bloch brand) for jazz. Students 10 & up will need (Bloch brand) suntan slip on tap shoes and jazz shoes. Lyrical students will need suntan split sole shoes. Hip-Hop classes will wear street shoes (any brand) and then be instructed on what shoes to purchase for the revue. Competition students will be notified on specific colors and styles. **All shoes must be labeled with dancers names.**

Competition Classes: All competitors will be required to wear a KKD practice uniform to EVERY competition class!!!

Private Lessons

We offer private lessons for students that would like to have the one on one with a teacher to improve their technique. ANY and ALL private lessons MUST be scheduled through Kelli regardless of what teacher is teaching the lesson.

CODE OF CONDUCT

All students and parents are expected to conduct themselves in a courteous and respectable manner at all times. Gossiping by a student or a parent about other students, parents, staff members or other studios is not tolerated. Disrespecting a faculty member or another student or being discourteous to a fellow student is grounds for disciplinary action that may result in probation, suspension or being asked to leave the studio permanently. In the event that you are asked to not return to the studio there will be no reimbursement for any classes, collected fees for the revue or any other fees collected by the studio. If your costume is paid in full but has not come in yet, we will call you when it comes in and you can come pick up the costume or costumes.
